Affiliate Honor Society Application

HISTORY & PURPOSE

The New Hampshire AFFILIATES Honor Society began in 1995.

The primary purpose of this Honor Society is to encourage broad participation among members in order that they might be better educated, active members, to serve their clients, and in return bring credit to themselves and our related industries. The program is designed for both the newer AFFILIATE as well as those who have held State membership for a number of years - it is not intended to reward those members who are not actively participating in AFFILIATE functions.

AWARDS

Members of the Honor Society will be awarded certificates and pins on an annual basis recognizing their membership in this Society. These certificates and pins will be presented to Affiliate Honor Society Members by their local Board of REALTORS®.

YEARLY QUALIFICATION

To maintain membership in the AFFILIATES Honor Society, members must re-qualify each year by obtaining 150 points. The Honor Society is designed to keep State members active and involved.

Following five consecutive years of Society membership, a member may miss one year without losing his/her five-year status. AFFILIATES who maintain their Society membership for 15 years will be recognized as lifetime members.

QUALIFICATION PERIOD

The qualification period is January 1 through December 31 of each year. Applications must be submitted each year to the local board for verification no later than **April 4, 2014** and forwarded onto State no later than **April 18, 2014**.

AFFILIATE HONOR SOCIETY QUALIFICATION

A minimum of 150 points per year is needed in order to qualify or maintain membership in the AFFILIATES HONOR SOCIETY.
