- 3. Secretary's Report D. Tanguay
 - a. **MOTION** to accept the minutes of the January 2024 Board of Directors meeting. **MOTION** was **SECONDED** and **APPROVED**.
- 4. President's Report Ethan Ash
 - a. President's Update

Matt Bacon pushed to set up liaison on NECPE Task Force. It was originally Data Policy Task force and now in transition to the new Catylist System. Allison will put on the agenda moving forward, the Transition to the New Catylist System. Matt L, Matt B, Nicole and Ethan Ash were on the standing committee for contract negotiations and then changed to Data Policy and now the new system. - Since the meeting in January there have been 4 new applicants all REALTORs.

- i) (Public Policy Committee/Government Affairs) D. Garvey
 There is a lot of legislation. 480HB addresses waiting time on calls at OPLC. The time is
 down for some, but tier 1 and 2 waiting time is up. OPLC wants to drop a dedicated person
 for REC. Lots of complaints haven't been touched in 6-7 months. It is not transparent.
 SB249 short term rental NHAR opposes. HB103 septic and site assessment NHAR is
 opposed. HB1362 rent stabilization comes back every year. Towns could institute rent
 control. NHAR opposes. HB 359 appeals by abutters. SB454 Transfer Tax into

Housing Fund.

Beth Fisher stepped down at Housing Appeals Board. They are looking for another real estate sales person. 25 cases pending.

j) (NHCIBOR Cares) – Laura Nesmith

Thanks to Scott, Joe, Jeff helping Cares to raise funds for our recent scholarships. 6 of them. Looking at applications.

k) (Forms) – Need Liaison

Len Foy is not a member of CIBOR anymore. Bill Jean may be the liaison. Laura Gandia is a lawyer and member of CIBOR. She agreed to secure a spot on Forms and PPC. Suzanne Brunelle will serve on Forms committee. Ethan and Bill will reach out.
